INVITATION TO TENDER – CAA IT Infrastructure

Introduction

1. Modernisation & Maintenance of the CAA IT Infrastructure

The CAA has an existing network infrastructure of hardware and software that has been purchased on an as-required basis, typically with a one year's support contract. The CAA has also built up a virtualised environment, namely VMware ESX, which is a major component of the infrastructure.

The infrastructure has grown to a size, for a small organisation, such that it requires suitable management. The infrastructure needs to be kept up to date and current and ideally managed more efficiently and effectively through one all-encompassing maintenance and support contract. The CAA is looking to contract with a vendor who fully understands the CAA's requirements and can maintain a long term service contract. This tender covers both the acquisition of the necessary hardware/software (excluding vSphere licences) and the support for that hardware and software.

Infrastructure Changes

1. Establish a back-up site at NCIT.
2. Establish industry best practices for the VMWare infrastructure including back-up processes
3. Establish shared storage (minimum 4 TB usable after RAID 1/5)
4. Establish VMWare high availability and vMotion capabilities for the infrastructure.
5. Establish a firewall with VPN and URL filtering
6. Migration of 1 physical server (domain controller) to virtual server
7. 1 year warranty for the works carried out under the contract
8. Support for the infrastructure for a period of 4 years

Hardware and Software

1. Licence for 1 x VMWare Learning Zone Premium
2. Licence for 1 x MS Windows Sever 2016
3. Additional server(s) for the use case, as applicable
4. Additional switch for the use case, as applicable
5. Additional security appliance for the use case, as applicable
6. Hardware warranty 3 years minimum
7. Hardware delivery within 3 months of contract signature. Awarded contractor shall sign the contract within 2 weeks of the contract being awarded.

2. Evaluation Criteria

Bids will be qualified based on a 60:40 (quality: price) ratio. Financial score is calculated as 40 * (cheapest price of all bidders / price for tender). Technical quality is evaluated using the table below:
