1. Purpose of this NPRM

The purpose of this NPRM is to make changes to the existing CAR Part 1 – Commencement and Interpretation, to give force of regulations through Civil Aviation Regulations to the proposed new regulations titled as Maldivian Civil Aviation Regulations.

2. Background to the Proposal

Following a regulation review study carried out by CAD, it has been recommended that new rules be developed to replace the existing rules to achieve full compliance with ICAO standards where possible and also to harmonise civil aviation regulations with internationally recognised standards.

CAD has decided to make significant changes to the existing regulatory in the manner described below.

Before publishing any new regulatory material, CAD will consult the industry by issuing a Notice of Proposed Rule Making (NPRM).

2.1 Regulatory Structure

The regulatory structure consists of the following publications.

- Maldives Civil Aviation Act, Act No 2/2001
- Maldivian Civil Aviation Regulations (MCAR)
- Air Safety Circulars (ASC)
- Civil Aviation Advisory Publications (CAAP)
- Exemptions from Regulations

2.2 Maldivian Civil Aviation Regulations

MCARs will replace existing Civil Aviation Regulations and Maldivian Airworthiness Requirements. When a new MCAR part has been published, the relevant CAR parts will be amended, giving references to the MCAR part and the MAR contents may need to be amended. It is anticipated that CAR and MAR will cease to exist by January 2009.

The structure of MCAR is given in Appendix 2. The MCAR parts will be developed by CAD, by adapting internationally recognised standards. When adapting internationally recognised standards, preference will be given to achieve harmonisation with European Standards (EASA standards).

2.3 Air Safety Circulars

MCAR parts would be accompanied by Air Safety Circulars that provide explanatory information and examples of how to comply with the rules. ASC's could also be used to issue emergency regulations or regulations which are temporary in nature. The numbering used for ASC's are as follows:

ASC 145-1: First ASC issued under MCAR 145 ASC 201-2: Second ASC (general) issued under MCAR 201

2.4 Civil Aviation Advisory Publications

CAAP's are used to publish voluminous advisory material or standards. A CAAP can only be published with the issue of an ASC or if it has reference with in an MCAR Part, which would explain the purpose of the particular CAAP.

All CAAP's are associated with a particular MCAR. One such example is given below.

CAAP 66-1: Engineer Licensing Guidance Document

2.5 Exemptions from Regulations

Exemptions allow relief from one or more requirements of a regulation. An exemption to a regulation can only be issued by CAD. The numbering to be used for issue of exemptions is as follows:

EXE/FCL-1: First exemption issued under MCAR FCL EXE/139-4: Fourth exemption issued under MCAR 139

CIVIL AVIATION REGULATIONS PART 1 – COMMENCEMENT AND INTERPRETATION

1.2.4 RULES OF CONSTRUCTION

- (a) In these Regulations unless the context otherwise requires:-
 - (1) the masculine gender imports the feminine gender;
 - (2) words used in the singular import the plural and words used in the plural import the singular;
 - (3) references to "by the regulations" or "under these Regulations" are references to "by or under these Regulations"
- (b) These Regulations may contain references to Maldivian Civil Aviation Regulations (MCARs) and such regulations (MCARs) shall take effect as if issued or published under these Regulations.
