2. Recommending Signatory Review

The review should be completed by the individual designated by your company. The company shall hold certification privileges (typically MCAR-145/CAO organisations), normally this would be a member of the quality department or similar. The review shall be carried out by the signatory and must not be delegated to the applicant or any other individual.
