SUBMISSION OF "ONLINE TRAVELLER DECLARATION FORM"

08th January 2024

1.0 Introduction

Maldives Immigration has made changes to the submission of online "Traveller Declaration Form" (The electronic Embarkation/Disembarkation card of the Maldives), which is now mandatory for all passengers and airline crew (Except Maldivian Citizens) arriving to and departing from the Maldives effective from 20th November 2023.

2.0 Purpose

The purpose of this Circular is to advise the airlines and aircraft operators operating to and from the Maldives on the latest changes to the completion & submission of online "Traveller Declaration Form" made by Maldives Immigration.

3.0 Requirements

As stipulated in the Maldives Immigration Circular number 94-CBS/CIR/2023/I which is attached Annex I.

4.0 Effectivity

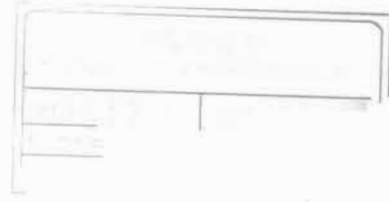
This Circular will come into effect from 09th January 2024 and will supersede Circular AT 01/2010 – Issue 01 dated 14th February 2010.

SUBMISSION OF "ONLINE TRAVELLER DECLARATION FORM"

1. Effective from 20th November 2023, submission of online "Traveller Declaration Form (The electronic Embarkation/Disembarkation card of the Maldives)", is mandatory for all passengers and airline crew (**Except Maldivian Citizens**) arriving to and departing from Maldives.
2. The purpose of this circular is to inform all international airlines, aircraft operators operating to and from the Maldives and to the relevant authorities in the Maldives, on submission of the online "Traveller Declaration Form", which is mandatory to all passengers and airline crew (**Except Maldivian Citizens**) arriving to and departing from Maldives by air.
3. The following announcement should be made inflight:
*"All arriving passengers (**Except Maldivian Citizens**) should complete and submit the online "Traveller Declaration form" via the online Immigration portal (IMUGA) "imuga.immigration.gov.mv" within 96 (Ninety-Six) hours before your arrival to the Maldives"*
4. All arriving passengers and airline crew (**Except Maldivian Citizens**) should complete and submit the online "Traveller Declaration Form" within 96 (Ninety-Six) hours before your arrival to the Maldives.
5. It is the responsibility of the Operating Airline to ensure that all of their passengers and airline crew (**Except Maldivian Citizens**) have completed and submitted the online "Traveller Declaration form" via the online Immigration portal (IMUGA) "imuga.immigration.gov.mv" prior to their boarding.

6. All departing passengers and airline crew (**Except Maldivian Citizens**) should complete and submit the online “Traveller Declaration Form” within 96 (Ninety-Six) hours before the time of their departure from Maldives.
7. The online “Traveller Declaration Form” is available via Maldives Immigration website portal <https://imuga.immigration.gov.mv>
8. The requirement in this circular applies to all international airlines, aircraft operators operating to and from the Maldives, passengers and airline crew (**Except Maldivian Citizens**) arriving to and departing from Maldives by air and to the relevant airport authorities in the Maldives.
9. Failure to comply the requirements of this circular, the operating airline will be penalized under the Immigration Act 1/2007.
10. As of 20th November 2023, the provisions outlined in this circular will come into effect. Furthermore, circular number 94-CB/CIR/2022/3 (10th November 2022) is hereby cancelled.
